Ref: Encouraging a World Bank Zero Deforestation Pledge

Dear Dr. Kim,

We, representing civil society organizations (CSOs) working to promote the conservation and sustainable use of forests and other natural ecosystems, to ensure the protection of rights for forest-dependent people, and to address the imminent threats of climate change, are writing to request the World Bank Group to make a **commitment to zero deforestation** in its lending portfolio.

Ending deforestation is essential to addressing the World Bank's twin goals of eliminating extreme poverty and promoting shared prosperity. An estimated 1.6 billion people depend on forests for their livelihoods which provide clean and abundant water, food and medicinal plants. Additionally, forests nourish the agriculture of nearly half the population of the developing world and provide critical mitigation and adaptation to climate change, which disproportionately impacts the world's poorest people.

Accompanying this letter is a "Declaration on Zero Deforestation in International Finance and Development" developed by the undersigned civil society organizations to guide the timing and implementation of such a commitment. The declaration includes ten goals to be reached over the next several years, including commitments related to ending illegal deforestation; availability of finance to support existing international commitments related to forests; measurement and reporting on forest impacts; community management of forest resources and community land rights; zero net deforestation; and zero financing of deforestation for a subset of sensitive forest habitats.

Given the unquestionable importance of forests in achieving climate and other goals, additional Bank actions we encourage the Bank to undertake to advance forests' contribution include:

- 1) a high-level Bank announcement supporting forests during COP21,
- 2) a progressive Forest Action Plan document, and
- 3) far stronger language on forests in the new Environmental and Social Framework.

To position the Bank as a global leader in climate change and forests, we encourage you to underscore at COP21 and beyond the importance of forests in climate change and poverty alleviation, and ideally commit to a zero deforestation goal in the World Bank Group's portfolio.

The Forest Action Plan currently under development by the World Bank to guide forest investments during FY2016-2020 represents a timely opportunity for the Bank to articulate a progressive agenda in forests, as a key resource for ending extreme poverty and achieving shared prosperity of rural communities, and we encourage the Bank to articulate ambitious goals, including zero deforestation, in this document. We welcome the FAP's inclusion of impacts on forests from other sectors at the Bank, as well as the incorporation of the crosscutting themes of climate, governance and rights.

Finally, we want to reiterate our serious concerns regarding the elimination of the Forests safeguard in the ongoing safeguard review process as well as the extremely limited requirements related to forests in the current draft ESS6 or Environmental and Social Framework.

We thank you in advance for considering these issues and would be very pleased to discuss the above requests further with you.
